## 1 Features

It combines years of experience and technical progress in a polishing motor designed for long life and daily use. For grinding, polishing, roughening, cleaning or brushing – fast and clean. And safe!

- two speeds: 1500 min<sup>-1</sup> resp. 3000 min<sup>-1</sup>
- extremely low-noise thanks to permanently lubricated ball bearing
- control lever with ball-knob– easy to operate, even with the ball of the thumb
- start-up from zero without any problems, smooth run-down
- very stable, no mounting necessary
- perfect power, even in continuous operation
- robust plastic powder coating
- optional connector available
- maintenance-free for life

### 5 Application

The WSM-2 polishing motor is a well-proven, efficient and maintenance-free single-phase AC motor (induction motor) with 2 speed options: 1500 rpm and 3000 rpm. It is fitted with low-noise, completely maintenance-free ball bearings. Shaft ends have 9 mm standard tapers for mounting the brush spindles.


Your polishing motor is designed for polishing dental products. The nuts on each side are used for undoing the polishing spindle and as a form of shaft protection.

Only use the device for this type of application.

## 6 Before Starting

### 6.1 Transport

Before transporting the unit, ensure that it has been unplugged from the power socket. Make sure that it is packed correctly in order to avoid accidental damage.


 Be sure to check for any transport damage when unpacking the goods. Note down any damage if found.


### 6.2 Installation

Open the box, remove the packing materials, and carefully lift out the device and accessories. Check the included accessories.

The device has to stand horizontally on a steady and even surface.

The location of your polishing motor is very important for its operational reliability, even if it is only to be stored there for a short time. The room should be dry, well ventilated and vibration-free. An even temperature and wooden base are desirable.

 Install the device in a place where it will not block the working area and the functionality (take the dimensions into account).


 Do not install the unit outdoors or in places without proper ventilation.

Before start-up, be sure the device reaches room temperature.

### 6.3 Storage

If the unit is to be stored for an extended period, protect it from moisture and dust.

## 7 Installation/ Start-up

 **Before** starting the unit, connect up the following:

### 7.1 Installing and Removing the Brush Spindles

To use the polishing motor, you have to install the brush spindles, and that involves first removing the nuts. Use a cloth to clean the shaft ends and then replace the nuts.

Use compressed air to remove dust and grime from the brush spindles.

Then install the spindles as marked: **L = left and R = right**. Use a hammer and a piece of plastic to tap the spindles lightly and carefully onto the end of the taper.


**Excessive force could damage the ball bearings and void the warranty.**

The spindles must run true when the motor is on. If they do not, repeat the above steps.

**Finally**, insert the power plug into the socket, making sure that the mains and the unit operate on the same voltage.

## 8 Operation

### 8.1 General Operating Instructions

 All instructions for using the unit, whether in verbal or written form, are based on our own experience and experimentation and can only be regarded as guidelines.

1. Connect the polishing motor to the mains.
2. Use the toggle switch to select the speed.

## 9 Troubleshooting

Fault	Cause	Solution
Ball bearing noise	Faulty bearings	Change bearings
Spindles slip	Spindles too loose	Tap spindles lightly with a hammer
Spindles can not be undone	Spindles too tight on taper	Contact Service



If the above recommendations do not solve the problem, contact your dental depot or our service department.

## 10 Care and Maintenance

### 10.1 Cleaning



Disconnect the power plug before starting any maintenance work.

The identification plate has always to be kept in easily legible condition and has not to be removed.



Remove external dirt from time to time with some form of cold cleaner.

Use only cold cleaners to avoid damaging the paintwork or removing the lettering. The equipment should be cleaned at regular intervals to ensure trouble-free operation.

It requires only normal cleaning (sponge, damp cloth, mild detergent) and no further chemical additives.

You should make sure that the bores of the nuts for the brush spindle stay clean. Be especially careful when polishing with pumice.

When undoing the nuts, remember that the **left side has a right-handed thread** and the **right side a left-handed thread**.



## 10.2 Maintenance

The unit does not require any servicing. Just make sure that the device is kept clean.

## 10.3 Repairs



Servicing or repairs to the unit has only to be carried out by qualified technicians. Only original spare parts are to be used. Responsibility for the product is voided if unauthorised persons alter it or if inappropriate components are installed.

## 10.7 Warranty
