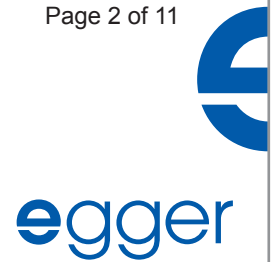

4.1 General information

SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Avoid generation of dust. Do not breathe dust/fume/gas/mist/vapours/spray. Provide adequate ventilation. Remove all sources of ignition. Use personal protection equipment. The accumulation in lowlying or closed rooms can cause increased danger of fire and explosion. The vapour of the product is heavier than air and may accumulate below ground level, in pits, channels and basements in higher concentration. In case of major fire and large quantities: Remove persons to safety.

6.2 Environmental precautions

Do not allow to enter into surface water or drains. Make sure spills can be contained, e.g. in sump pallets or kerbed areas. Discharge into the environment must be avoided.

6.3 Methods and material for containment and cleaning up

Spilled product must never be returned to the original container for recycling. Prevent spread over a wide area (e.g. by containment or oil barriers). Soak up inert absorbent and dispose as waste requiring special attention.

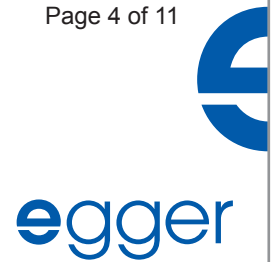

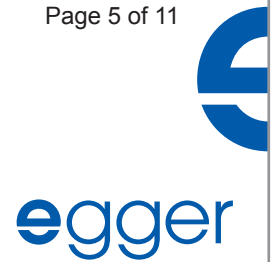

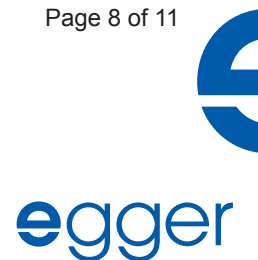
